# TERMS & CONDITIONS

- Yearly Memberships are Guaranteed one (1) charter per calendar month over the duration of the membership
- Memberships that are paid in full may use more than 1 charter in a calendar month (based on availability), not to exceed the allotment of charters in their membership
- Membership begins on the date of purchase
- Memberships will be frozen immediately upon missed payment. Subject to processing fees
- Memberships are non-transferrable
- Charters must be used prior to Membership expiration date. No refunds on unused charters
- Gratuity, private chef (where applicable), provisions, shopping fee will be charged to the card on file and are payable in full at the time of reservation
- No refunds on Private chef, provisions or shopping fees
- A security deposit of \$1200 is required at the time of the charter and will be charged to the card on file
- \* Special Considerations: (Freeze or Transfer)  
Members may freeze or transfer a membership up to three (3) months during one (1) year under certain circumstances
  - Hard Times - Financial Distress - Freeze only
  - Temporary Injury/Illness - Short term injury or illness
  - Terminal/Injury or Illness - May Transfer to beneficiary
  - Death - Transfer to Other Family Member beneficiary named in contract. (must transfer within 3 months)
